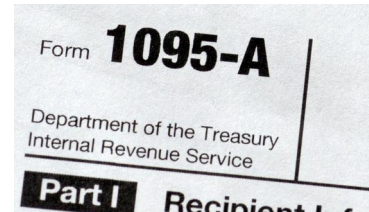
### Welcome to Benefit Briefs

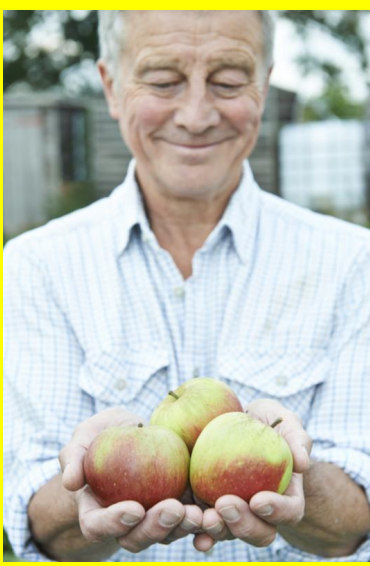
